Several passes of a light spray each allowed to dry is more effective when treating non-porous surfaces.

Crawling insects: Spray around and behind fixtures and fittings or as a 'barrier' treatment around doors and windows.

'Resting' flying pests: Apply to areas and surfaces where flying pests are seen to rest.
